#### What is a Modern Apprenticeship?

They are an exciting way of gaining skills and qualifications that will help to start a career without having to study full-time, A Modern Apprentice need to be employer they will learning on the job and off the job, working towards a qualification. All Modern Apprenticeships are developed by the industry or sector in which they will be used. Modern Apprenticeships are offer those aged over sixteen.

### Who are they for?

Modern Apprenticeships in Hairdressing are aimed at those over 16 and capable of achieving a Scottish Vocational Qualification at Level 2 or above and core skill at Level 3 or above.

## Am I Eligible for Modern Apprenticeship?

If you are aged 16 to 24 you can apply to become MA. However, you cannot apply for an MA if you are:

- At school, college, or university full-time
- Have already achieved an SVQ in Hairdressing up to level 3/ SCQF 6.
   However, if you have achieved a SVQ in Hairdressing level 2/ SCQF 5 they you can become an MA at level 3.
- An overseas national who is subject to an employment restriction or to a time limit on your stay in Great Britain – or both. But if you are a refugee or asylum seeker, you can apply.
- Already on an employment, training or enterprise scheme that is funded by the government or Skills Development Scotland.
  - In custody as a prisoner, or on remand.

## What are SVQs?

Scottish Vocational Qualifications (SVQs) are work-based qualifications and tell you exactly what you must do in a job to do it well. They are based on national standards which are drawn up by people from industry, commerce, and education. This means that if you have an SVQ, then you have a way of proving that you can do your job well, to national standards agreed. An SVQs send powerful messages to employers:

- You can do your job confidently and well.
- You are motivated, confident, and ambitious.
  - You are ready to take on responsibility.
    - You are committed to your work.



#### What are Core Skills?

Core skills are the broad, transferable skills that help you to develop the main skills that you will need in life and work. Core skills may have been achieved at school Scottish candidates will have been issued with a Core Skills profile in their Scottish Qualifications Certificate. Candidates who have already achieved Core Skills at the levels given above do not need to repeat these as part of their Modern Apprenticeship framework.
